#### **ORDINARY BUSINESS**

### 1. Welcome and Acknowledgement of Country

- A quorum having been achieved (64 Members), the meeting was declared open at 6:02 pm (AEDT).
   Members were advised to contact Computershare on +61 3 9415 4024 for assistance, if required, at any time during the meeting.
- The President and Chair, Dr Catriona Davis-McCabe, acknowledged the traditional owners and custodians of country throughout Australia.
- Dr Davis-McCabe further acknowledged those with personal experience of mental health issues, and the importance of lived experience in the work of the APS.
- Dr Davis-McCabe introduced the Board Directors, Returning Officer, Audit Partner and Election Adjudicator present at the meeting.
- Members were advised that all resolutions of the meeting would be decided by poll, inclusive of valid proxy votes cast. Members were advised of the process for voting and for asking online questions.
- The Notice convening the Annual General Meeting was distributed by email to Members on 25 October 2024 and published, along with meeting papers, on the APS website. The Notice was taken as read.

## 2. Minutes of the Annual General Meeting 15 November 2023

Dr Davis-McCabe reported that the minutes of the previous Annual General Meeting held on 15
November 2023, as published on the APS website for inspection by Members, had been approved by the
Board and signed by the President as Chair of the Annual General Meeting.

### 3. Reports and Financial Statements

#### 3.1 President's Report

- At the end of her term of office, Dr Davis-McCabe reflected on the privilege and honour of serving as APS
  President.
- Dr Davis-McCabe indicated that the APS achievements, over her tenure, of which she was most proud, included the securing of crucial funding and government recognition for key initiatives to better support the psychology profession, the establishment of focused presidential taskforces and the renaming of the Division of Professional Psychology in recognition of the evolution of a diverse profession.
- Dr Davis-McCabe acknowledged the support of the Chief Executive Officer and all APS staff and thanked Members for the expert advice, perspectives and encouragement which inform and inspire the work of the APS.
- Dr Davis-McCabe wished the incoming President and Board the very best in bringing new energy and ideas to continue the advancement of the psychology profession.

#### **Annual Report**

Members received the 2024 Annual Report video, highlighting key achievements over the past year.

### 3.2 Chief Executive Officer's Report

- The Chief Executive Officer, Dr Zena Burgess, reflected on the work of the APS over 2024, supported by consultation with individual Members and Member Groups. Dr Burgess acknowledged the valuable work undertaken by those Members who have served on taskforces and working groups contributing to an inclusive and representative organisation.
- Dr Burgess thanked the Executive Leadership Team for their efforts in another successful year of advocacy, growth and recognition.



• Dr Burgess thanked the departing President, Dr Davis-McCabe, for her open and collaborative leadership and welcomed the incoming President, Dr Sara Quinn, and new Board members.

# 3.3 Finance, Investment & Audit Committee Chair's Report

- The Finance, Investment & Audit Committee Chair, Mr Mark McEnallay, provided an overview of financial performance for the 2023-2024 year and financial position as at 30 June 2024, as detailed in the financial statements published on the APS website.
- The deficit of \$2.26 million for the year was attributed to continued investment in the APS's digital transformation program, cost-of-living impacts on membership numbers and events/professional development revenue. Mr McEnallay advised that the overall position as at 30 June 2024 was strong, with significant realisable cash and investment balances offsetting operating liabilities. The APS's Auditor issued an unqualified report for the reporting period.
- Members received the APS financial statements, Directors' report and Auditor's report for the financial year ended 30 June 2024.

#### 4. Member Questions

 Question: There has been a 33.5% increase in marketing costs. Could you please comment on what is driving this?

<u>Response</u> (Mr Harry Georgalas, Chief Operating Officer, Company Secretary): Marketing costs for the 2023-2024 year were attributable to the APS rebranding exercise (currently paused), marketing of events/conferences and general publicity/promotion.

- Question: What are the current Directors' fees?
  - Response (Mr Georgalas): In the order of \$30,000 per annum per director plus superannuation.
- Question: What is the President's remuneration?
  - Response (Dr Davis-McCabe): In the order of \$100,000 per annum plus superannuation.
- Question: This year, Interest Group fees were waived. Will this impact financials for those Groups?
   Response (Mr Georgalas): This initiative was designed to offer value and choice to Member Groups and there is no impact on funds available to Interest Groups for their activities.
- Question: What has happened to the mentoring program for new psychologists?
   Response (Dr Burgess): The mentoring program continues to operate. Those wishing to participate should contact the Chief Executive Officer or General Manager Member Experience.
- Question: What other reasons (i.e. other than financial) are Members giving for not renewing their membership? How is this information gathered and what percentage of people leaving are contacted?
   Response (Dr Davis-McCabe and Dr Burgess): The primary reasons given are cost-of-living impacts, retirement and the APS White Paper/Medicare 'two-tier' issue. Staff contact Members soliciting feedback on non-renewal whenever possible.
