Part 1: Participation Information

What is this project about?

The Autism CRC is leading the update of the 'National Guideline for Assessment and Diagnosis of Autism Spectrum Disorders in Australia'. A draft version of the updated Guideline has been developed based on both research and consultation with the community. The draft Guideline includes a set of Recommendations and Good Practice Points for practitioners that are intended to guide diagnostic decision-making and the comprehensive assessment of individual support needs.

Why are you being invited to participate?

We want to hear feedback from all community members on the draft version of the updated Guideline. You are invited to provide your feedback on the draft Guideline via an online form. Your feedback may inform revisions to the Guideline, to make it better.

Who can participate in the research?

We warmly invite feedback on the draft version of the updated Guideline from the following community members/groups, aged 18 years and over:

- People on the autism spectrum/autistic people.
- Parents, caregivers, and family members of individuals on the autism spectrum.
- Practitioners involved in assessment and/or diagnosis of autism across the lifespan.
- Members of organisations/bodies/groups that are involved in assessment and/or diagnosis of autism.
- Organisations/bodies/groups that are involved in assessment and/or diagnosis of autism.
- Other members of the autism community (e.g., informal support people, service providers, researchers).

How can I participate?

- You can submit your own response, as an individual.
- You can contribute to a shared response, within an organisation. If you contribute to a shared response within an organisation, you can still submit your own individual response as well.

What would I need to do?

1. Understand the project and your role

You are reading this Participant Information Statement, because your organisation is planning to submit a response that reflects the views of the organisation.

2. Read the draft Guideline

The team has also made available different options for you to share your feedback on the draft Guideline. For individual submissions, only anonymous feedback will be used and reported. For organisation submissions, only the name of the organisation will be published alongside the feedback.

Part 2: Ethical Information we must provide you.

What will be done with the information you provide?

- 1. We will use it to revise the updated Guideline: Feedback on each section and each Recommendation will be considered alongside the evidence collected through the original Guideline development process and the update process. We will read all written responses you provide using the designated online survey. To ensure that everyone providing feedback has the same opportunity, and to ensure that the Guideline Development Group considers all feedback equally, we will only consider feedback provided via the online form and we make no undertaking to review (and will not respond to) any further information referred to via links (e.g., weblinks, resources).
- 2. We will provide a de-identified copy of all responses to the National Health and Medical Research Council. This is a requirement for the development and update of clinical guidelines in Australia. All feedback collected from the community through this process will be submitted anonymously to the NHMRC. The NHMRC uses this information to evaluate how the Public Consultation occurred and how the information gathered was used, when they decide whether or not to approve the updated Guideline.
- 3. We will publish your organisation's name, a copy of your feedback, and our response, when the updated Guideline is released. This is <u>not</u> optional. By making a submission on behalf of an organisation you agree to the use of the information in this way. We will publish your responses verbatim, but reserve the right to redact any potentially personally identifying or defamatory information.

What type of feedback will you receive?

For organisational submissions, you will see a brief response from the Guideline Development Group to your feedback, when the updated Guideline is published. The Guideline Development Group will only provide feedback in this form and will not enter into additional correspondence regarding the feedback. By submitting feedback, you are acknowledging that this is the limit of feedback that will be provided.

How will privacy be protected?

The conduct of this research involves the collection, access, storage and/or use of your identified personal information. The information collected is confidential and will not be disclosed to third parties without your consent, except to meet government, legal or other regulatory authority requirements. A de-identified copy of this data may be used for other research purposes, including publishing openly (e.g. in an open access repository). However, your anonymity will at all times be safeguarded. To conduct a Lead Practitioner Diagnostic Evaluation, psychologists are recommended to have a relevant area of practice endorsement, and/or competence in the assessment and diagnosis of neurodevelopmental conditions as demonstrated by appropriate qualifications, training and experience.

The APS as the peak body for psychologists requests this change to ensure that clients have access to appropriately skilled psychologists who are competent to conduct the Lead Practitioner Diagnostic Assessment, noting that there are competent registered psychologists with advanced qualifications, training and experience in autism who do not have an area of practice endorsement or who have areas of practice endorsement other than clinical psychology, educational and developmental psychology or clinical neuropsychology.

We note that statements about the importance of early intervention have been removed from this section and it is unclear why this is the case. Diagnosis and intervention at any stage in the lifespan can be of value to people with autism and their families. However, research, policy and early intervention programs (e.g., NDIS early childhood approach for children under 7) all speak to the benefit of children with autism being identified and supported early in life. We recommend that early intervention is referred to in this section and practitioners be encouraged to discuss this with clients and families as part of the pros and cons for assessment and diagnosis.

The Diagnostic Evaluation should involve practitioners with specified medical and/or allied health qualifications, combined with advanced training and/or experience relevant to the differential diagnosis of autism from a range of neurodevelopmental and behavioural conditions.

In 55.2, correct reference to the psychologist requirements for Lead Practitioner Diagnostic Evaluation to reflect the changes we have requested above in Feedback on Key Section: Foundations of Assessment and below in Other Feedback about Appendix 2.2

Correct Appendix 2.2 to reflect Ahpra training, registration and protected title requirements.

- Training change to: Successfully completed a six-year sequence of education and training which includes a 4-year Australian Psychology Accreditation Council (APAC) endorsed university degree, followed by: 2 years of supervised professional training, or a 5th and 6th year higher degree or a 5th year higher degree plus a 1-year internship. Psychologists who hold an area of practice endorsement (e.g., clinical psychology, educational and developmental psychology or clinical neuropsychology) have advanced training in a specific area of practice, having completed a postgraduate qualification and a registrar program in an approved area of practice.
- Registration or membership remove from "OR" onwards as this essentially repeats the first statement and inadvertently suggests there are separate Ahpra registration requirements for the three named areas of practice endorsement.
- Three areas of practice endorsement as examples is appropriate in the context of this Guideline but must align with Ahpra-protected titles: educational and developmental psychology (not educational/development psychologist.
